OPERATIONS MANUAL

The Institute hires the Infrastructure of existing, competent and experienced training Institutes to conduct training programmes on its own.

One of the requirements for hiring the facilities is that the premises where the training activities are to be conducted is that the infrastructure should be either owned by the applicant Institute/ leased to the applicant Institute and/or in the occupation of the applicant Institute as per a legally binding understanding with the owner of the premises.

Accordingly, the applicant Institute has to submit an authentic copy of the Title/Ownership Deed/Lease Deed or understanding with the owner for conduct of the training activities in his/her premises. In case of the latter, the proof of ownership of the party with which understanding has been reached should also be invariably submitted in scanned copy forward with self-certificate along with photographs of the campus showing the classrooms and other facilities available.

The legal status (Proprietorship/Partnership/Trust/HUF/ Society Act with Registration under relevant Act/ Section 25 in the Companies Act) of the Institute/ Organization is also required to be submitted along with the contact details of the main personnel of the Institute.

The Infrastructure Provider should be identified ideally through a physical visit or else by email exchanging. The dimensions of the venue should be carefully checked on. The mandatory scale is a minimum area of 2500sq ft.though bigger area could be required for a larger conduction. In addition, sufficient equipments should also be there for the proper conduct of the training programme. For e.g. if a training of computer related programme is to be conducted, then the Institute is mandatorily supposed to have 30 computers. It may also be noted that we have fulfill the mandate of providing up to 70% employment to the trainees (primarily self employment).

The internet facility in the campus is mandatory.

Further, the course content will be provided by NIESBUD."
