INTRODUCTION

There has been a great deal of emphasis on developing entrepreneurship in the country to promote first generation entrepreneurs. Realizing the effective role of entrepreneurship in the process of industrialization in the developed countries, India and others developing nations viewed this as an effective measure to develop entrepreneurship to promote national production, balanced regional development, and dispersal of economic power and provide better employment opportunities.

The Jan Shikshan Sansthan (JSS), MSDE, Government of India is working for the upliftment of the non –literates, neo-literates, unskilled and unemployed youth particularly from the SC/ST/OBC/ Minority/ Divyang/Women throughout the country especially to underprivileged people in the rural areas. The purpose is to bring the transformation in the economic and social life of the underprivileged people in the rural and urban areas through skill development and enhancement initiatives in their areas.

The EDP training initiative will help the new and potential entrepreneurs to establish and manage their enterprises successfully. Responding to the above, it become a urge of the day that entrepreneurship must be promoted among the bottom of the pyramid of society both in the rural and urban areas.

The Jan Shikshan Sansthan (JSS), MSDE, Government of India has launched a Entrepreneurship Development Programme (EDP) for the JSS Trainees at PAN India, which is an outcome-oriented project. It aims to implement develop and promote entrepreneurship among the trainees of JSS in the country and create the entrepreneurs in the rural areas. The project is being implemented in mission mode and is aligned with the overall objectives of creating the entrepreneurs in the rural areas.

NIESBUD has been sanctioned project for strengthening the entrepreneurship ecosystem for the upliftment of the non –literates, neo-literates, unskilled and unemployed youth particularly from the SC/ST/OBC/ Minority/ Divyang /Women throughout the country especially to underprivileged people in the rural areas.

Under one of the activity EDP for JSS Trainees Project sanctioned to NIESBUD the

institutes conducting Entrepreneurship Development Programme for the trainees of JSS followed by mentoring and handholding to trainees who have strong desire to pursue entrepreneurial opportunities.

The initiative targets and envisages outcome in the form of establishment of Nano and Micro Enterprises and creative the suitable wage employment.

The EDP being organized for the JSS Trainees is spread over a 5 days and aims at imparting to the learners a thorough insight into the various aspects of enterprise creation, technical know-how, credit sources, and marketing of products and changing trends of market current scenario. The programme will make the participants to understand the concepts of identification/ selection of projects and setting up of own enterprise so as to run their business successfully. While the programme incorporates a thorough briefing on Government support systems, it also includes additional benefits of being an Entrepreneur.

The institute has organized Entrepreneurship Development Programme for JSS Trainees at VARANASI, UTTAR PRADESH from 17.06.2023 to 22.6.2023.

OBJECTIVES

The objectives of the training programme were:

- To impart Knowledge on Entrepreneurship;
- To acquaint the participants about entrepreneurial opportunities;
- To make aware the participants about the entrepreneurial support ecosystem;
- To impart knowledge to participants on selecting the suitable entity for their enterprise;
- To make participants acquainted with the procedures and formalities for availing financial assistance from banks;
- To impart knowledge and skills to participants on essential elements required for preparation of project report;
- To impart knowledge on necessary managerial skills required to run the enterprise;
- To provide post-training assistance through Mentoring and handholding support.

PROGRAMME METHODOLOGY


FEEDBACK OF THE PARTCIPANTS








6.Are you already engaged in some informal business activity?




